ORDER

WHEREAS, the learned Civil Judge & Judicial Magistrate-I, Kazi Ahmed reported vide letters No.44 of 2024, dated 18.01.2024, No.61 of 2024, dated 20.01.2024 with regard to absence of delinquent Raju Sweeper and letter No.249 of 2024, dated 25.03.2024 about continuous absence of delinquent from his duty on 03.03.2024, 04.03.2024, 11.03.2024 and thereafter since 14.03.2024 without intimation or leave.

AND WHEREAS, learned Civil Judge & Judicial Magistrate-I, Kazi Ahmed reported vide letters No.329 of 2024, dated 17.4.2024, No.431 of 2024 dated 07.05.2024, No.CJ & JM-I/-530, dated 03.06.2024, No.904/CJ & JM-I, dated 27.08.2024 and a joint report of learned Civil Judge & Judicial Magistrate-I & II, Kazi Ahmed vide No.CJ-JM-I-K.A 1283 dated 23.11.2024 that delinquent is absent since March, 2024 upto date without any prior leave or intimation.

AND WHEREAS, Show Cause Notice under Rule 5 (iii) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973 bearing No.EB/SHOW-CAUSE/-9838, dated 24.12.2014 was issued and served upon Raju, Sweeper under the provision of Sindh Civil Servants (Efficiency & Discipline) Rules, 1973 on ground of 'misconduct' & 'inefficiency' and reply thereof was furnished by him on 07.01.2025 but he has neither denied his absence nor furnished reasonable or justifiable cause and only promised that no complaint would raise against him in future. However, irony is that the incumbent still did not mend his ways and once again learned Civil Judge & Judicial Magistrate-I, Kazi Ahmed vide letter No.CJ & JM-I, K.A/-69 of 2025, dated 13.01.2025 reported that delinquent has not been attending his duty since March 2024 till to yet.

AND WHEREAS, the undersigned being competent Authority after affording more than sufficient opportunities to delinquent Official and perusing the record has come to the conclusion that the delinquent Official is liable to be imposed major penalty of "Compulsory retirement", prescribed in Rule 4(1)(b)(ii) of the Sindh Civil Servants (Efficiency and Discipline) Rules, 1973,

AND WHEREAS, the undersigned being District & Sessions Judge, Shaheed Benazir Abad/ Authority, after considering the facts of the matter and providing more than sufficient opportunities to delinquent Official, in exercise of the powers under Rule 5(4)(b)(ii) of the Sindh Civil Servants (Efficiency and Discipline) Rules, 1973, has decided to impose major penalty of "Compulsory retirement", prescribed in Rule 4(1)(b)(ii) of the Sindh Civil Servants (Efficiency and Discipline) Rules, 1973, upon him.

NOW THEREFORE, the penalty of "Compulsory retirement", prescribed in Rule 4(1)(b)(ii) of the Sindh Civil Servants (Efficiency and Discipline) Rules, 1973 is hereby imposed upon Mr. Raju, Sweeper, with immediate effect.
